

EMODnet Seabed Habitats updates

The European Marine Observation and Data Network (EMODnet) is financed by the European Union under Regulation (EU) No 508/2014 of the European Parliament and of the Council of 15 May 2014 on the European Maritime and Fisheries Fund.

Status update (on thematic)

- New layers available online under 'Composite data products'
 - 8 layers showing the official 2018 reported distributions of Annex I habitats (produced by EEA)
 - latest version (2020) of the official OSPAR Threatened and/or Declining Habitats data product
 - 8 layers showing Important marine habitats in Norway (produced by MAREANO)
- 54 new point datasets or habitat maps from survey collated and about to be published: Denmark (1), France (28), Germany (1), Ireland (2), Italy (2), Poland (2), Portugal (4), Romania (5), Spain (2), UK (17).
- Together with EMODnet Biology, we developed a standardised approach for users submitting habitat observations to EurOBIS
- Update of the interactive map view with several functionality improvements
 - Layer search
 - New tools added to the map toolbar: 'go to lat/long', 'measure'
 - Clearer tool icons in the map toolbar and the layer-specific toolbars



Cross-Thematic Interactions

- Collaboration with EMODnet Biology to standardised approach for users submitting habitat observations to EurOBIS
 - Guidance document available on the EMODnet Seabed Habitats portal
- EMODnet Geology
 - The Seabed substrate product is a key input to EUSeaMap
 - In July, EMODnet Geology provided us with an early copy of the product
 - Collaboration on classification of additional seafloor surface feature planned for next phase
- Cross-thematic sessions at the Jamboree with EMODnet Biology and Geology

External interactions

 OSPAR: ongoing interaction with members of the Intersessional Correspondence Group for Coordination of Biodiversity Assessment and Monitoring (ICG-COBAM) to develop a data product showing the best available data on the extent of EUNIS habitat types in the North-east Atlantic.

• EEA:

- Provided feedback and recommendations to correct and improve the EUNIS 2019 marine classification
- Requested improvements to the provision of controlled vocabularies for EUNIS classification.
- OBIS: suggested updates to manual to include EMODnet recommended approach to record seabed habitat types.
- Caspian Sea data owners: we have begun reaching out to potential data owners in the Caspian Sea ahead of the next phase.


- Update of seabed substrate
