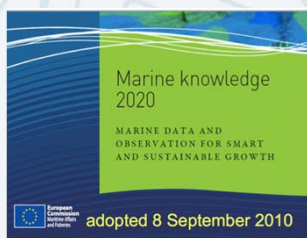

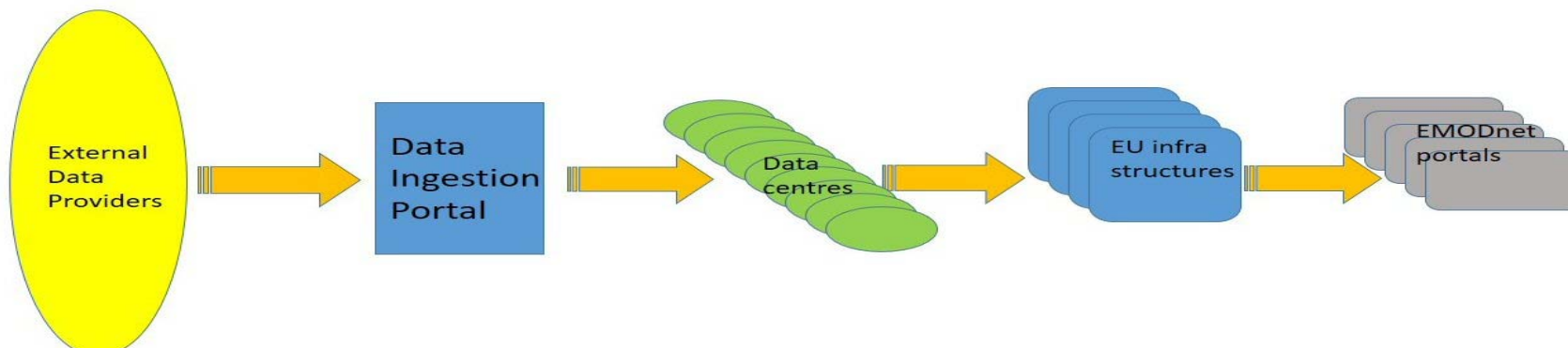
Welcome to the EMODnet Data Ingestion portal

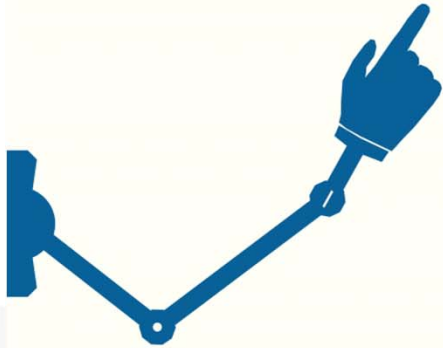

Ingestion primary focus = data providers/data sets not yet handled as part of the mainstream processes of the EMODnet data centres

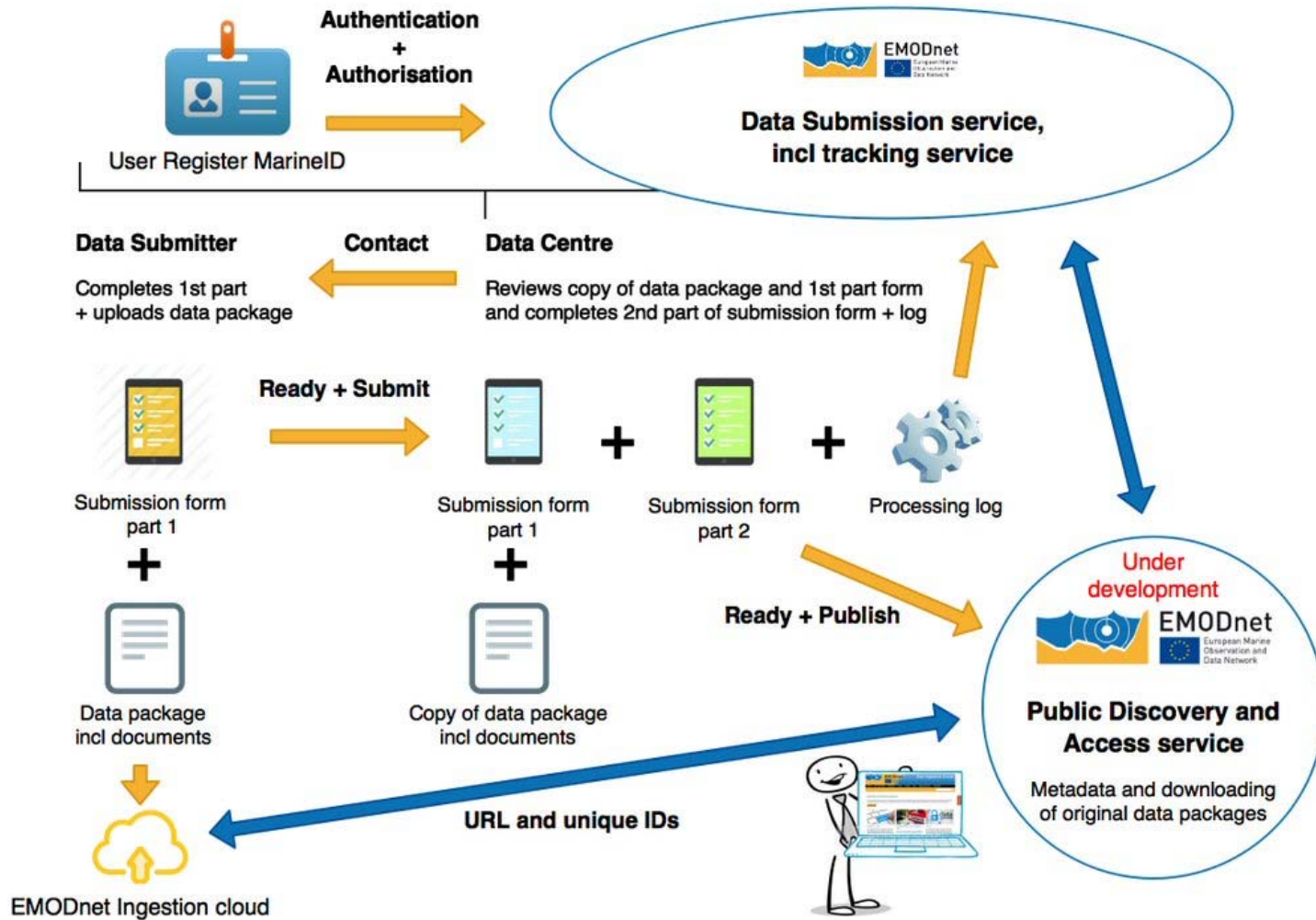

Multi-day EOOS Conference – 21-23/11/18 Brussels

- present in an integrated way the results of checkpoints & other studies delivering recommendations for future priorities for ocean observation; and
- provide a wider perspective and forward look on the development of EOOS + assess progress and identify further actions

- Establish a Structured EMODnet-EOOS Dialogue (SEED)
- Explore and identify specific joint actions of mutual benefit





Coordinating framework intended to

- ① Align and connect existing initiatives to ensure efficiency and value for money;
- ① Identify gaps in the European observing capacity and foster initiatives to fill those gaps;
- ① Promote observing capacities which can benefit multiple sectors including research, policy, management and industry; and
- ① Ensure that European ocean observing is integrated into the global observation system(s) by providing a focal point for interaction with international programmes and partner initiatives outside of Europe.

How?

- Strategy and Implementation Plan under development
