1. Introduction

Údarás na Gaeltachta invites expressions of interest (EOI) from potential project promoters in the marine sector who may be interested in establishing a presence at Páirc na Mara, a Marine Innovation Park in Cill Chiaráin, Connemara, Co. Galway.

The purpose of this EOI is to assist Údarás na Gaeltachta in preparing a suitable development plan for the site and:

- To provide an opportunity for private enterprises public agencies to contribute to and/or participate in the development of enterprise space, commercial office, light industrial/workshop and commercial marine and renewable based rental opportunities which will be developed at Páirc na Mara;
- To inform the overall design of Páirc na Mara which will be planned, developed, resourced and managed so to encourage synergies and efficiencies in developing the e marine sector locally and on a regional basis;
- To assist in identifying specialised requirements amongst prospective clients that could inform the planning and the resourcing of facilities and infrastructure at Páirc na Mara;
- To identify requirements in the marine community for marine uses that complement the core objectives relating to the planning of Páirc na Mara;
- To identify potential suitable employment creating projects, developed through public and private investment, in the marine sector which could be developed at Páirc na Mara.

2. Background information on Páirc na Mara

Páirc na Mara will be developed as a state of the art, low carbon, Marine Innovation Park, located in Cill Chiaráin, Co. Galway (please see map in Appendix A). The facility will encompass a variety of marine related activities, where productive sector enterprises , public bodies, state development agencies and the research community will work together to add value to their products and services and to maximise the development potential of the marine sector in the region

The site which will accommodate the Marine Innovation Park comprises approximately 9.01ha. Cill Chiaráin is located on the southern edge of the Connemara Gaeltacht approximately 45 miles from Galway City which affords views of ceantar na nOileán.

An tÚdarás through its own resources has funded preparatory and enabling works on the development site. An tÚdarás are committed to ensuring that s this area is recognised as a prime, strategic location for consolidating, preserving, and growing Ireland's , maritime industries and industrial enterprises drawing on the marine resource locally.

It is envisaged that the development at Páirc na Mara of marine related facilities and supporting infrastructure will support the expansion and development of the marine resource sector in West Conamara. It is further envisaged that it will become a key enabler for the development of the overall marine industry not only in Cill Chiaráin and Conamara but also at a regional and national level.

3. Páirc na Mara's Objectives

In line with stated government policy, the development of Páirc na Mara's will drive the sustainable growth of the Marine economy locally, within the region and the country.

The development of the site is expected to have the following impacts:

- Encourage more marine related start-up enterprises by providing incubation and development infrastructure including access to specialised educational, training and research programmes,
- Accelerate the upscaling of existing Small and Medium-Sized Enterprises (SME) through access to shared infrastructure and development supports and facilitating access to targeted business development opportunities within the sector
- Attract foreign direct investment to the sector and the region by encouraging enterprises to locate at Páirc na Mara and by encouraging strategic financial investment in existing and start-up firms.
- Consolidation of the aquaculture industry in the area through building on existing strengths while addressing current constraints;
- Increased sustainable employment locally and in the region and encouraging greater settlement and demographic growth in the rural catchment areas;
- Increased demand for goods and services locally;

4. Potential Infrastructure and Services to be provided

It is envisaged that Páirc na Mara will provide various opportunities for engagement through a variety of tenancy and affiliation categories and, these may include those listed in the table below:

TYPE	DESCRIPTION
Tenant	Medium to long-term lease of dedicated office space and/or workshop space including long-term leaseholds on serviced sites
Occasional User	Occasional use of facilities including office, workshop space or research facilities rented by the day/week/month and/or use of shared workshops, boardrooms and marine and renewable facilities
Membership	Membership to access programmes, networks and services. Note that all tenants and users are also members.
Incubator	Facility and services for marine and renewable start-ups to accelerate their development through programmes, incubation, funding opportunities, expertise and mentoring.

respondent will not be returned.


d. Confidential Information of Údarás na Gaeltachta

Appendix A



Guidelines for EOI submissions

Please provide the following information as appropriate in your EOI submission to assist in the development of Páirc na Mara.

Provide a description of your organisation and proposed use, including:

- 1. Contact information
- 2. Market segment(s) of interest
- 3. Continuity of requirement at Páirc na Mara (for eg.: short term license or long-term lease, occasional use of the facilities, little use of the facilities but affiliation to program as member)
- 4. Nature and scale of space requirements (facilities, office, workshops)
 - a. Marine and Renewable facilities:
 - i. Requirement for berthage, marine facilities, laydown space.
 - ii. Vessel size;
 - iii. Power and water service requirements;
 - iv. Desired laydown space;
 - v. Depth requirements;
 - vi. Other desired marine facilities specifications.
 - vii.Employee requirements number & educational requirements

b. Start-Up Incubation Client

- i. Start-up status (sales and team size);
- ii. General description of business, product(s) services and customers;
- iii. Stage of development (idea, proof-of-concept, prototype, and technology readiness level;
- iv. Programming interest (mentoring, workshops, expert advice, funding opportunities);
- v. Contribution to community/culture
- vi.Employee requirements number and their educational or training requirements or stipulated qualifications

c. Office space:

- i. Requirement for dedicated office space for daily or regular use, or shared office for occasional or intermittent use;
