


# **Global Sea level trend**





- ✓ In 2023, switch from current DU to Serverless Object Storage Marine Data Store
- ✓ Impact on users to be anticipated: largest ever user transition

Benefit for users

- ✓ No more data volume treshhold for large download (MY)
- ✓ Faster download, faster subsetting, more scalability: chunk data in any dimension, reduced latency
- ✓ Faster viewing, full resolution view from viewer, all file supported in viewer (static files such as bathymetry, OMIs, in situ, SL L3 along track)
- ✓ More APIs available for coders, Machine to Machine API without authentication
