
From the point of view of the tenderers, selection in two phases:

Procurement Board Mandate

 The Procurement Board appointed by the Stakeholder Board, which will oversee the common and national procurement processes, under the responsibility of the Coordinator, and will be composed by partners representing more than 60% of the contribution needed for the common procurement and supported by the legal expertise of the partners. Terms of Reference (TOR), if needed, will be approved by the Stakeholder Board before the end of Phase 1.
