- WP1 Project Management

1. The Consortium Agreement (13 August, 2009) is at the moment signed by 7 out of eight partners (signature University Bremen still missing). The First payment has been transferred to seven partners (payment to Ifremer in progress).
2. Much effort has been spent the last months in organising the Biological Data Products Workshop. This workshop will take place 25-26 of February in Ostend and will 1) discuss the marine biological (monitoring) data availability and gaps in Europe and 2) define a set of derived data products relevant for private bodies, public authorities and researchers. The workshop will focus on

various species groups (phyto-and zooplankton, benthos, macroalgae, higher

plants, seabirds, marine mammals and sea turtles). The preparatory action covers the Greater North Sea (including the English Channel and

Skagerrak-Kattegat), the Bay of Biscay and the Iberian Coast.

This workshop will result in a set of key-recommendations that will be implem

ented in the further development of the preparatory action for biological data. Based on the identification of relevant data products, targeted data analysis wo rkshops will be organised in the near future.

At this moment 65 experts from science, policy and practice were invited. So far 42 people agreed to join the workshop, 9 persons are unable to attend. From 14 persons, we still await a final answer. We have a good geographic and thematic representation (with a focus on the focus area of EMODNet, Biological) of marine biological experts. The workshop will have representatives from Belgium, Netherlands, Spain, France, Germany, UK, Greece, Ireland, Sweden, Italy, Ukraine, Russia. Also representatives from

EU, ESF-Marine Board, ICES, OSPAR, Black Sea Commission and HELCOM will join the workshop (check appendix for provisional participant list).

 - c. The data inventory was sent around by Prof. Heip to all partners of the MARS (<http://www.marsnetwork.org/institutes.php>) Network. So far, we received feedback from France (University Montpellier) Sweden (Kristineberg Marine Research Station, Marine Ecology/Göteborg University) and Ireland (Marine Institute).
6. GAP-analysis II: a detailed gap analysis of the European Ocean Biogeographic Information System (EurOBIS) is in progress.
