### Panel 2b: Fish well

The panel will explore the next steps in the cooperation amongst riparian countries in the Black Sea region on fisheries issues, notably in the context of the GFCM and the implementation of its Mid-term Strategy (2017-2020) towards the sustainability of Mediterranean and Black Sea Fisheries. It will also take stock of the implementation of the Bucharest Declaration adopted in October 2016 which stes objectives aiming to establish a common and collaborative approach to cooperation amongst riparian countries in the Black Sea region with a view to promote the rational exploitation of marine living resources, the sustainable development of aquaculture and the mitigation of threats facing the marine environment and vulnerable species. In this respect focus will be given on on-going actions to improve the sustainability of resources, particularly with regard to scientific advice, sustainable small-scale fisheries, MCS, capacity building, as well as actions emanating from a Regional Plan of Action to fight IUU fishing.
