- Large programme area disparities




- EU political instrument for promoting economic, social and territorial cohesion in the Atlantic Area

Strategic Value of the Interreg Atlantic Area Projects 2014-2020

- ✓ Helped to reduce regional disparities and increases cohesion in such a scattered territory.
- ✓ Created real added value to transnational cooperation: The notion of working together to tackle common issues in the AA has been intensified
- ✓ Increased dialogue among different and relevant stakeholders and engagement
- ✓ Built trust across borders and fosters AA Member States for being more competitive in specific economic areas
- ✓ Contributed and improved the inclusion of the AA's region in an specific strategy





2014-2020 Interreg Atlantic Area's Projects:

Strategic Value of the Interreg Atlantic Area Projects 2014-2020

- ✓ Delivered territorial cohesion: results on new knowledge, shared experiences and enhanced capacities
- ✓ Have supported regions and cities to make better use of their resources.
- ✓ Enabled regions and cities to jointly tackle challenges that go beyond borders
- ✓ Worked as facilitator for further public and private investment
- ✓ Triggered policy making and change





2014-2020 Interreg Atlantic Area's Projects:

The Programme and the Atlantic Maritime Strategy

- ✓ The Atlantic Area Programme is geographically covered by a Sea Basin Strategy, the Atlantic Strategy
- ✓ The thematic objectives of the Atlantic Area Programme are quite aligned with the priority axes of the Strategy
- ✓ Applications to the Interreg Atlantic Area: a specific field in the application form about the Atlantic Strategy. Circa 96% (both calls) of applicants answered their projects are in line with the Atlantic Maritime Strategy
- ✓ The FUTURE: the opportunity for a better geographical and thematic synergy between European Territorial Cooperation (ETC) Programmes and Strategies
