



## Progress on data and geographic coverage



- Known existing data from countries outside of the EU -> seeking diplomatic support/strategy
- Some deep sea waters are poorly considered and have not been the object of systematic survey ->
  suggest that EU science funded project are getting "archived" through EMODnet.
- Temporal component of the bathymetric information needs to be taken into account (especially in coastal waters) -> technical visualisation solution (where overlapping data exists), estimate the bathymetry satellite informations – where possible (cf EMODnet Bathy/Copernicus Marine ongoing discussions).
