

The EU4Ocean Platform aims to build a more informed, engaged, and sustainable ocean community in Europe and beyond. It facilitates dialogue and cooperation among stakeholders through workshops, conferences, and networking events.

The EU4Ocean Platform works in close collaboration with the two other EU4Ocean communities – the **Youth4Ocean Forum** and the **Network of European Blue Schools**.



WHAT ARE THE CRITERIA OF ELIGIBILITY TO BECOME A MEMBER OF THE EU4Ocean PLATFORM?



Are you a European stakeholder involved in ocean literacy? Are you interested in becoming a member of the EU4Ocean platform? If so, you'll need to demonstrate your ability and willingness to meet a series of **eligibility criteria**.

It is important to note that stakeholders have a diversity of skills and resources, so you are not required to meet all eligibility criteria. However, you should strive to provide motivation, explanation, and concrete evidence to meet as many eligibility criteria as possible.

It's important to recognize that each stakeholder will bring specific skill-sets and offer multiple methods and levels of engagement. Some organisations may be willing to play a fully active role from the start, while others may need time to develop awareness, capacity, and resources in their country or sector. Individuals and organisations with an interest, but no prior experience in Ocean Literacy, or lack of access to resources, can also engage and feel part of the EU4Ocean Platform without commitment or active resource contribution.

To be eligible, you'll need to demonstrate your ability and willingness to contribute to the cause.

- You should represent a key target group such as science, policy makers and decision-makers, industry and business, financial institutions, media, civil society, art and culture, educational organizations, and initiatives;
- You should be able to explain how your sector or domain can contribute to the
 efforts of the EU4Ocean Platform and the wider coalition;
- You should already be actively working in the area of Ocean Literacy;
- Show how your organisation's efforts contribute to developing Ocean Literacy in Europe and provide examples of your work;
- Be motivated and able to contribute resources and/or funding, and be open to forming new partnerships;
- You should also demonstrate your motivation and capacity to contribute to relevant Ocean Literacy activities of the EU4Ocean Platform;
- You should integrate **youth** into all activities and be willing to **mentor** them.

I WOULD LIKE TO JOIN THE EU40cean PLATFORM AS AN INDIVIDUAL. IS THIS POSSIBLE?

WHAT ARE THE GUIDING PRINCIPLES OF THE EU40cean COALITION?



- **Leadership** for European Ocean Literacy: driven by active, motivated organisations and communities that can provide leadership, guidance and catalyse engagement in Ocean Literacy in Europe.
- **Inclusive**: connecting and empowering communities for real change.
- · Shared responsibility for ocean preservation and engagement of all stakeholders and wider society.
- Open and free access to information and sharing of resources.
- A strong **voice for youth** with a strong pillar of youth engagement and leadership reversing the traditional top-down relationship between adults and the Youth to a fair and balanced relationship.
- Raising the profile of **marine and maritime education** in mainstream education.
- **Innovative** in forming new partnerships, joint actions and co-designing new tools and solutions, building on existing activities and best practice.
- European focus, contributing to the delivery of the European Green Deal, but with an international reach and
 contribution. EU4Ocean Coalition activities are implemented in the context of the UN 2030 Agenda and the Sustainable
 Development Goals (SDGs), together with the UN Decade of Ocean Science for Sustainable Development and UNESCO
 activities in international Ocean Literacy.

HOW COULD WE/I CONTRIBUTE TO THE EU40cean COALITION?



As a member of the EU4Ocean Platform, you would have **no legal obligations**, **but your active participation would be highly encouraged**.

One of the great benefits of being a member of the EU4Ocean Platform is the opportunity to participate in a **variety of events** and activities organised by the EU4Ocean Coalition. You would be invited to contribute to joint initiatives and participate in calls to action and expression of interest for the **Challenge of the Year**, all on a voluntary basis. Moreover, you could share with other members updates on your work, upcoming events, and calls for contributions. This would be a great opportunity to network with others across Europe and across sectors and potentially collaborate on **co-designed initiatives**. By contributing to online discussions and Platform meetings, you would be able to share your expertise and work together with other members towards a common goal. Additionally, you could propose a **commitment** to a particular activity or initiative that aligns with your interests. You would also have the opportunity to contribute to **coaching and mentoring activities** for **Young Ocean Advocates of the Youth4Ocean Forum**, or support the **Network of European Blue Schools** by contributing to **teachers' training.**


If your proposal is selected, you'll receive **seed funding** to help turn your vision into reality. Of course, additional funding may be required to fully implement your initiative.

HOW IS EU40cean LINKED TO EUROPEAN UNION POLICIES AND INITIATIVES RELATED TO THE OCEAN?



Through its actions, the EU4Ocean Coalition directly contributes to the objectives of numerous European Union policies and initiatives related to the ocean, and in particular to:

- the European Union Mission 'Restore our Ocean and Waters' which aims to protect and restore the health of our ocean and waters through research and innovation, citizen engagement and blue investments;
- the European Green Deal, including, amongst others, objectives related to climate change, protection of biodiversity and ecosystems and a healthy food system for people and the planet; and
- the new approach for a sustainable blue economy in the European Union.



HOW IS EU40cean LINKED TO INITIATIVES ON OCEAN LITERACY AT THE INTERNATIONAL LEVEL?



EU40cean, a collaboration between the **European Commission, EU40cean partners, and the UNESCO Intergovernmental Oceanographic Commission**, is Europe's Ocean literacy hub. Starting in 2022, the alliance aims to enhance ocean literacy activities across the globe to empower society to take action for the ocean.

EU40cean aligns with the United Nations Decade of Ocean Science for Sustainable Development (2021-2030). This global initiative aims at reversing the declining cycle of ocean health and promoting sustainable development by bringing together ocean stakeholders worldwide under a common framework, ensuring ocean science supports actors in creating improved conditions for the ocean's sustainable development.
